To do that the GHRRA may disclose personal information about yourself, the Stud Manager, the Stud Dog and/or the owner of the Stud Dog to other persons or other organisations including law enforcement bodies, State Governments, other licensing authorities and other racing authorities, Clubs and controlling bodies (located within and outside of Australia).

You do not have to supply the information requested in this application or by the GHRRA from time to time in processing this application, but if the information (or any part of it) is not provided, your application may be rejected by GHRRA.

By completing and submitting the application and any supporting documentation, you hereby authorise the GHRRA to collect, use and disclose the information contained in this application and any supporting documentation and/or to disclose any information about the Stud Manager, the Stud Dog and/or the owner of the Stud Dog for the purposes and to the persons/organisations described above and for the general purpose of promoting greyhound racing.
