COMMENT: Won by the second favourite CAPTAIN FLASH(3). The favourite OUT FOR FIVE(6) finished seventh.

INCIDENTS: JOASKY'S REVENGE(5), NUNDLE BOY(7) and BLACK PLUNDER(8) were slowly away. KEVIN'S PROBLEM(1) struck the running rail at the first turn before shifting out and checking JOASKY'S REVENGE(5), NUNDLE BOY(7) and BLACK PLUNDER(8). OUT FOR FIVE(6) shifted wide at the turn into the back straight. BLACK PLUNDER(8) checked off the heels of BONNIE'S DESTINY(2) and BITOLA STAR(4) approaching the home turn. JOASKY'S REVENGE(5) and OUT FOR FIVE(6) collided in the home straight. A veterinary examination of KEVIN'S PROBLEM(1) revealed no injury.

COMMENT: Won by GOODS IN CUSTODY(2). The favourite MISS EVELYN(4) finished sixth. The second favourite YELTSIN'S KISS(3) finished fifth.

INCIDENTS: MISS EVELYN(4) checked YELTSIN'S KISS(3) shortly after the start. EIFELLA LEE(8) checked POISON FLOWS(6) approaching the turn into the back straight. POISON FLOWS(6) galloped on the heels of RIPPLE AGOGO(1) approaching the home turn. RIPPLE AGOGO(1) struck the running rail at the home turn before spearing out and colliding with POISON FLOWS(6) and in turn hampering MISS EVELYN(4). BUCKY BEAVER(7) lost ground during the event to finish last. A veterinary examination of BUCKY BEAVER(7) revealed an injured off side hip with an incapacitation certificate issued for ten days from 19.6.09. The winner GOODS IN CUSTODY(2) was locked away and a urine specimen to be obtained.

The photo finish failed to operate on this event with the placings semaphored in accordance with the Judges placings.

COMMENT: Won by DON'T TOUCH IT(1). The favourite LATE NIGHT OUT(5) finished fourth. The second favourite COUNTER STRIKE(4) finished fifth.

INCIDENTS: DON'T TOUCH IT(1) jumped smartly and led throughout. MY DAD'S COOL(7) and BLACKLOCK(8) came together at the start. PREMIER TOURIST(2), SHANTAE(3), COUNTER STRIKE(4) and LATE NIGHT OUT(5) came together shortly after the start. PREMIER TOURIST(2) and LITTLE LUCIFER(9) collided at the first turn causing LITTLE LUCIFER(9) to fall which in turn caused MY DAD'S COOL(7) to fall checking COUNTER STRIKE(4) and BLACKLOCK(8). A veterinary examination of LITTLE LUCIFER(9) revealed a broken near side leg with an incapacitation certificate issued for 10 days. A veterinary examination of MY DAD'S COOL(7) revealed a minor abrasion with no stand down period required. A veterinary examination of LATE NIGHT OUT(5) revealed an injured near side shoulder with an incapacitation certificate issued for ten days from 19.6.09.
