RACE 1 MICKA LEE(9) not required.

RACE 2 STEELY JACK(4) reported injured 10.00 a.m. 19.6.09. Incapacitation certificate issued for ten days from 22.6.09 up to and including 1.7.09. Replaced by TIGER BOND(9).
SUNRISE GEM(7) reported sick 8.27 a.m. 22.6.09. Incapacitation certificate issued for ten days from 22.6.09 up to and including 1.7.09. Replaced by SHY BOND(10).

RACE 1 GBOTA WELCOME STAKE – 4TH GDE – 520M

COMMENT: Won by COOL AUSSIE(3). The favourite LAST MAN OUT(4) finished seventh. The second favourite COME ON IZZI(7) finished fourth.

INCIDENTS: LAST MAN OUT(4) was slowly away. COOL AUSSIE(3) hampered DANDALOO COWGIRL(2) soon after the start. EMMA BITES(1), LAST MAN OUT(4), MAIN ROAD(6), MCKEW(5) and COME ON IZZI(7) checked at the first turn with LAST MAN OUT(4) and MAIN ROAD(6) the worst affected and soon after LAST MAN OUT(4) galloped on the heels of MAIN ROAD(6) causing both greyhounds to be checked severely. Veterinary examination of LAST MAN OUT(4) revealed an injured off hind leg. Incapacitation certificate issued for ten days from 22.6.09. The winner COOL AUSSIE(3) was locked away and a urine specimen to be obtained as a random ballot winner.

RACE 2 MULTQUIP STAKE – 5TH GDE – 520M

COMMENT: Won by SHY BOND(10). The favourite DROVER(2) finished second. The second favourite CAWBOURNE TUF(8) finished fourth.

INCIDENTS: CAWBOURNE TUF(8) was slowly away. TEENY TINY(5) hampered DROVER(2) at the first turn where SILVER CITY JAKE(3) checked CAWBOURNE TUF(8). CAWBOURNE TUF(8) checked COOL QUALITY(1) in the back straight. DROVER(2) collided with the running rail at the home turn and soon after checked off the heels of SHY BOND(10). Veterinary examination of SILVER CITY JAKE(3) revealed no injury. Stewards interviewed the trainer of SHY BOND(10) regarding the greyhounds improved performance tonight. The trainer informed Stewards that the greyhound had struck bad interference at its previous start where the greyhound had been drawn inside. The Trainer informed Stewards that the greyhound does enjoy racing from wide boxes. Stewards directed the greyhound be locked away for a urine specimen to be obtained.

RACE 3 GLOBE MEMORIAL STAKE – 5TH GDE – 520M

COMMENT: Won by HEAR NO EVIL(8). The favourite DOMINO VITALI(3) finished last. The second favourite PROVEN JETT(7) finished fourth.

INCIDENTS: FREDDY LEE(5) and PROVEN JETT(7) were slowly away. DRAGONFLY(4) checked FREDDY LEE(5) in the run to the first turn. DOMINO VITALI(3), FREDDY LEE(5), CHILLI PUG(6) and DRAGONFLY(4) checked at the first turn with CHILLI PUG(6) and DRAGONFLY(4) the worst affected. DOMINO VITALI(3) galloped on the heels of FREDDY LEE(5) at the turn into the back straight and again at the turn out of the back straight. BRAZEN JOURNEY(2) checked PROVEN JETT(7) approaching the turn out of the back straight. Veterinary examination of DOMINO VITALI(3) revealed no injury.

INCIDENTS: GLORIOUS GEM(6) and COOL LION HEART(10) were slowly away. LUKEKELY MAGIC(7) checked GLORIOUS GEM(6) soon after the start. FREE PARIS(9), RAILING(3) and GLORIOUS GEM(6) checked at the first turn. RAILING(3) hampered THAI DREAM(8) at the home turn.

RACE 5 NICE PRODUCTS BLUE PAWS FINAL – 4/5TH GDE – 520M

COMMENT: Won by BOSS NUMBER ONE(2) equal second favourite with QUICKLEE TOMMY(7) which finished second. The favourite ROUGH 'EM UP(1) finished third.

INCIDENTS: BALI'S BOND(8) was slowly away. PENNY'S PICK(6) checked ASTEROID LEE(5) soon after the start. POUNCE(4), BEST OF ELITE(3), ASTEROID LEE(5) and BALI'S BOND(8) checked at the first turn. ASTEROID LEE(5) hampered BEST OF ELITE(3) at the turn out of the back straight. Stewards interviewed the connections of ASTEROID LEE(5) regarding the greyhounds actions at the turn out of the back straight. Stewards subsequently issued benefit of doubt regarding marring and directed that the greyhound perform in a satisfactory trial with three other greyhounds before being permitted to nominate.
