Incidents: PATRICK LANE [7] and RELEASE [8] came together soon after the start. FOREST EAGLE [5] raced wide in first turn. MISTY RAIN [6] checked heels RELEASE [8] in the back straight, causing both greyhounds to lose ground. PUNTA DE LOBOS [1] and PATRICK LANE [7] came together in turn out of the back straight. FOREST EAGLE [5] raced wide in home straight.

Veterinary examination of FOREST EAGLE [5] revealed no injury.

### RACE 2 HARCOURTS REAL ESTATE STAKE 5 Gd 520M 16:11

Incidents: VICTOR LANE [1] checked SLIP BUY [9] in the run to the first turn, causing SLIP BUY [9] to race wide in first turn. HOTEL SPLENDID [4] checked heels MISS PERCEPTION [2] in turn into the back straight, causing HOTEL SPLENDID [4] to check MISS FALZON [3] and hamper SLIP BUY [9], resulting in MISS PERCEPTION [2], HOTEL SPLENDID [4], MISS FALZON [3] and SLIP BUY [9] losing ground. EXOTIC MISS [7] checked off heels of RUNAWAY PROMISES [5] in the home straight.

The winner of this event RUNAWAY PROMISES [5] was locked away for a urine sample to be obtained later in the meeting as a random swab greyhound.

BEST PLAYER [5] and JARMANE [6] came together in the home turn.  
JARMANE [6] checked PEGGY'S CHOICE [2] in the home straight.

Stewards interviewed connections of the greyhound JARMANE [6] regarding the greyhounds actions in the home straight.

After viewing the video replay of this event Stewards advised connections that they believe the greyhound did turn it's head outwardly in the home straight toward PEGGY'S CHOICE [2], however did not make head or muzzle contact.

Stewards subsequently deemed the performance of the greyhound JARMANE [6] to be unsatisfactory and made the greyhound subject to a satisfactory trial in accordance with GAR72 before being eligible to nominate for future events.
