Incidents: MOON'S LAW (3) hampered JESSIE'S TAIL (4) shortly after the start. VICTOR LANE (5) raced wide in the run to the first turn hampering VALLEY HI (6) and PROMETHEUS (7). JESSIE'S TAIL (4) checked VALLEY HI (6) and EXOTIC MISS (8) on the first turn. A post-race veterinary examination of VICTOR LANE (5) revealed the greyhound had injured the offside fore pad and connections were issued a 7-day incapacitation certificate, from 1.07.09 up to and including 7.07.09.

Incidents: IRINKA DENISE (1) jumped smartly and led all the way. FRED BOND (4) was slow to begin. RAGUSO REASON (7) checked FRED BOND (4), DAZZLE BOND (5) and CATHERINE ROSE (6) on the turn into the back straight. GYPSY PEPPER (10) checked FRED BOND (4) and DAZZLE BOND (5) on the turn off the back straight.

RACE 11 **SKY RACING STAKE 5TH GDE** **450M**

Incidents: MARLEY LANE (5) jumped smartly and led all the way. PANDORA LANE (3) and NATIONAL GUARD (7) were both very slow to begin losing valuable ground. MADAM JESSIE (1), IRINKA DAVID (4), SECRET SPIRIT (6) and ROYAL SCOUT (8) all checked on the turn into the back straight, worst affected was IRINKA DAVID (4). NATIONAL GUARD (7) galloped on the back of SECRET SPIRIT (6) down the back straight causing SECRET SPIRIT (6) to lose ground. MARLEY LANE (5) the winner of the event, was locked away for a urine sample to be obtained under the Greyhound and Harness Racing Regulatory Authorities random ballot policy. IRINKA DAVID (4) was examined by the club's veterinary surgeon after the event and no injury was found. A post-race veterinary examination of MADAM JESSIE (1) revealed the greyhound had lacerations to the offside foreleg and connections were issued a 10-day incapacitation certificate, from 1.07.09 up to and including 10.07.09.
